

## **OFFICIAL RULES OF THE ROLLING THUNDER RAFFLE**

By entering the Rolling Thunder Texas # 1 Raffle (“the Raffle”), you consent to be bound by these Official Rules. Accordingly, you should read these rules carefully before entering the Raffle.

1. **CONDUCTING RAFFLE:** The Raffle is being conducted by Steven Holt, a member of Rolling Thunder Texas # 1; Steven Holt is solely responsible for the raffle, the administration of these Official Rules, and the awarding of the prizes. All net proceeds from the Raffle will be distributed through Rolling Thunder Inc. Charities (501 C-3). Funds will be used within the State of Texas for Veterans, active military and their families in need of assistance.
2. **ELIGIBILITY:** To be eligible to enter the Raffle, you must comply with the Official Rules and either be a resident of Texas or purchase your ticket in person in Texas.
3. **HOW TO ENTER:** You have not entered the Raffle until your entry submission, with full payment, has been accepted and received by Rolling Thunder. Acceptance of your entry will be communicated to you by delivery of a ticket stub from Rolling Thunder. If a submission is accepted, then it will be deemed to have been accepted on the date and time on which the submission was received by a Raffle or Rolling Thunder volunteer. You may enter as often as you want, but all entry requirements must be met for each entry. Tickets will be sold until the funds from all 350 tickets have been delivered.
4. **THERE IS ONLY ONE WAY TO SUBMIT YOUR ENTRY:**  
Purchase your ticket in person from an authorized volunteer of the Raffle or Rolling Thunder volunteers by completing the official entry form, and handing the completed official entry form, along with cash, check, money order, or required credit card information, to one of the Raffle or Rolling Thunder volunteers present
5. **ODDS OF WINNING:**  
The odds of winning the Grand Prize will not exceed 1 out of 350, but may be more favorable depending on the number of entries.
  - a. The Drawing will be within 10 (Ten) business days of the sale of the 350<sup>th</sup> ticket.
  - b. One ticket will be drawn for each prize
  - c. The prize drawing order shall be determined by the value of the prize. The most valuable prize first, as determined by the President of Rolling Thunder, until all prizes have been awarded
  - d. The winning ticket of each prize **will not** be placed back in the drawings.
6. **PROCEDURES FOR LIMITING ENTRIES:** The number of entries into the Raffle shall be limited to 350 using the following procedure:
  - a. Rolling Thunder shall keep a tally of the number of tickets received and accepted.
    - i. if the tally results in there being more than 350 tickets accepted, then
    - ii. Rolling Thunder shall randomly select from all accepted tickets received in order to achieve exactly 350 accepted submissions.
  - b. All tickets in excess of the 350th ticket will receive a full refund.
7. **METHOD FOR AWARDING GRAND PRIZE:** Rolling Thunder will conduct a drawing, as outlined in 5a above, for all Prizes. The date and time will be announced on Rolling Thunder’s and or Pro Powersports of Conroe’s websites. All winning ticket numbers will be posted on Rolling Thunder’s website.
8. **You need not be present at the drawing to win.** All prizes will be available at Pro Powersports of Conroe located in Conroe Texas. All prizes must be picked up within 30 days of the drawing. All prizes not claimed within 31 days of the drawing become the sole property of Steven Holt.
9. **PRIZES:** None of the prize can be substituted by the winner.
10. **GENERAL CONDITIONS :**
  - a. The winner must execute and provide:
    - i. an Affidavit of Eligibility, attesting to the winner’s eligibility and compliance with the Official Rules;
    - ii. a Liability Release, releasing the Sponsors (as defined below) from any

- liability arising out of the Raffle; and
  - iii. A Publicity Release, allowing Rolling Thunder and or Pro Powersports of Conroe to use the winner's name, likeness, voice and biographical information for publicity purposes. The winners also will be required to provide any other information needed by Rolling Thunder to comply with applicable laws and regulations, including those relating to the payment of any and or all taxes. By accepting a prize, the winner grants Rolling Thunder and or Pro Powersports of Conroe's permission for the use of his/her name, likeness and biographical information for advertising and promotional purposes without additional compensation, except where prohibited by law.
  - b. The Raffle reserves the right, exercisable upon its sole discretion, to disqualify any individual found to have
    - i. violated these Official Rules;
    - ii. interfered with the entry process or the operation of the Raffle;
    - iii. altered or attempted to alter the random outcome of the Raffle;
    - iv. violated any law or regulation by participating in the Raffle; or
    - v. fraudulently completed the entry form or provided other false information.
  - c. IN NO EVENT WILL STEVEN HOLT, ROLLING THUNDER, PRO POWERSPORTS OF CONROE OR ITS BOARD MEMBERS, AGENTS VOLENTEERS OR EMPLOYEES (COLLECTIVELY, "SPONSORS"), BE LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND, INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, STATUTORY OR PUNITIVE DAMAGES. WITHOUT LIMITING THE FOREGOING, WITH RESPECT TO THE RAFFLE AND TO THE PRIZES, THE SPONSORS MAKE NO WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
  - d. **All taxes, fees, assessments, title and registration fees, insurance, and like charges, associated with the receipt or use of the prize are the sole responsibility of the winner. There is no cash value available to the winner of any prize.**
  - e. The value of the prize is based upon good faith estimates by Steven Holt as of the date the Raffle was commenced. The Sponsors assume no responsibility for changes in market conditions that may impact the value of the prize. There is no guaranty that a winner will be able to sell the prize for the estimated value or that the IRS, or its counterpart in any state's jurisdiction, will accept the value of the prize for purposes of determining any tax that may be due by the winner.
  - f. Entrants hereby fully release the Sponsors from any and all liability caused by or resulting from the use or possession of any prize awarded or caused by or resulting from participation in the Raffle or any related promotion.
  - g. Rolling Thunder and Pro Powersports of Conroe assumes no responsibility for lost, late, misdirected or undelivered entry submissions.
11. **DISPUTE RESOLUTION:** Venue of any action brought concerning the Raffle shall be in Conroe, Texas, and shall not be subject to transfer to another venue or locale for any reason. By entering the Raffle, you agree that you will not commence or participate in any class action litigation, or join with any other person in a legal proceeding, concerning the Raffle. The Raffle, these Official Rules, the entire relationship between you and Steven Holt, Rolling Thunder or Pro Powersports of Conroe, and any legal proceeding arising there from (whether based on contract, tort, law or equity), shall be governed by, construed in accordance with, and enforced pursuant to, the laws of the State of Texas, without regard to its conflict of laws principles.
12. **AMENDMENT OF RULES:** If, for any reason, the administration, security, fairness, or integrity of the Raffle has been compromised, Steven Holt reserves the right, exercisable only with the approval of Rolling Thunder Texas # 1, to cancel, terminate, modify or suspend the Raffle.
